

Privacy policy

On May 25, 2018, the General Data Protection Regulation (GDPR) began to be applied in Croatia, Regulation (EU) 2016/679 on the protection of individuals with regard to the processing of personal data and on the free movement of such data. It is directly applicable and will replace the existing legal framework. In accordance with the Data Protection Regulation (hereinafter: the Regulation), we have aligned our business activities related to the processing and protection of personal data, as regulated by this Privacy Policy for the Money Motion conference (hereinafter: the Policy). The Money Motion Conference (Short Notice Productions d.o.o.) (hereinafter: the Conference) at its headquarters at Slavonska Avenija 6, 10000 Zagreb, as the controller of your personal data, uses and protects all information that you provide to us when using the website <https://www.money-motion.eu/>.

Personal data is any information relating to a specific natural person or a natural person who can be identified. Specifically, personal data includes all data used to identify the user (for example, name and surname, email address, home address, etc.). Processing of personal data is any action or set of actions performed on personal data, either by automated means or not, such as collection, recording, organization, storage, adaptation or modification, retrieval, consultation, use, disclosure through transmission, publishing or otherwise making available, aligning or combining, blocking, deleting or destroying, and performing logical, mathematical and other operations with such data.

The purpose of the processing of your personal data is the registration of visitors to the Conference. The Conference is required to keep a record of its visitors with mandatory personal data of name, surname, and may contain other data belonging to personal data. The personal data that the Conference collects from you are:

- name and surname,
- email address,
- personal identification number - OIB,

In accordance with the purpose of processing, the Conference will process your personal data exclusively for:

- checking the right of access to the Conference
- checking the obligation to pay the ticket
- checking the accuracy and correctness or updating personal data,
- telephone or email communication with visitors if the payment made has incorrectly stated personal data

In addition, your personal data will not be disclosed to third parties, except in cases where it is necessary for the realization of the purpose of processing, or in cases where it is required by law. The Conference will keep your personal data for the period necessary for the realization of the purpose of processing, and after that for the period necessary to fulfill the legal obligation. You have the right to request from the Conference access to and rectification or erasure of personal data or restriction of processing concerning you or to object to processing as well as the right to data portability. You also have the right to withdraw your consent at any time, without affecting the lawfulness of processing based on consent before its withdrawal. You have the right to file a complaint with the supervisory authority at any time. The Conference will periodically review and update this Policy in accordance with the applicable legal provisions. The Conference will not use your personal data for automated decision making and profiling.

The Conference may collect and use non-personal data for statistical and analytical purposes, such as tracking the number of visits to the website or the number of clicks on a specific link. Non-personal data is data that cannot be used to identify a specific natural person.

The Conference may use cookies on its website. Cookies are small text files that are stored on your computer or mobile device when you visit a website. They are used to improve the functionality of the website and to provide information to the website owner. You can choose to disable cookies or to receive a notification when cookies are sent to your device. However, please note that some features of the website may not function properly if cookies are disabled.

The Conference may use third-party services, such as Google Analytics, to collect and analyze data on website usage. These third-party services may use cookies and may collect and use non-personal data for their own purposes. The Conference is not responsible for the privacy practices of these third-party services.

The Conference may update this Privacy Policy from time to time. Any updates to this Privacy Policy will be published on the website. We encourage you to review this Privacy Policy regularly to stay informed about how we are protecting your personal data.
